General Notes:

It appears that the new Cast machines are an improvement over the old ones.

There were several counts that were off by one throughout the county but most were well explained in the Inspectors' Statement, and were a matter of a poll worker taking a jammed ballot from the back of the unit and sending the ballot through the tabulator a second time without noting if the screen stated if the ballot had been counted or not.

A few municipalities closed the polls, then closed the election in error prior to printing enough results tapes.

In order to have a continuous tape from opening of polls to closing of polls the Zero Report should not be torn off. THREE signatures are required at the opening and closing of polls. If three signature lines do not print, the poll was opened incorrectly.

REMINDER: Chief Inspectors are <u>in charge</u> on election day. Municipal clerks should never take on that responsibility, but should be available to answer questions, provide supplies, and support.

Poll workers should not discourage voters from using the Clear Access machine.

Returned original poll books (signed copy) to the County Clerk's office should be printed on three hole punch paper.

Many clerks took advantage of using the Clear Access machine to print additional ballots when they realized the may have been running low. Please contact the County Clerk if you need more education on how to do this. This can be used in every election except where a partisan office is on the ballot.
