Congratulations on your election to the Sheboygan County Board! I'm looking forward to working with you on the many challenges and opportunities ahead, and appreciate your support as your new Chairperson.

I'm pleased to share that the Executive Committee unanimously supported my committee appointments. As you know, I can't give everyone what they want. INTRODUCTION OF DEPARTMENT HEADS

Mr. Payne welcomed newly elected Supervisors Rebecca Clarke, Jacob Immel, George Kulow, Marilyn Montemayor, Vicky Schneider, Wendy Schobert, and Brian Smith. Mr. Payne then introduced the Department Heads via a slide presentation and gave a brief description of their respective department budgets and staffing. Mr. Payne noted we continue to have healthy

fiscal reserves and strong fiscal track-record and complimented the County Board and Department Heads for establishing a culture of collaboration which is a key to our success. Lastly, Mr. Payne reviewed some significant accomplishments over the last four years, and presented outgoing Chairperson Wegner with a plaque for his impressive leadership and dedicated public service.

MAIN MOTIONS (Adoption of Rules)

Supervisor Nelson moved to adopt Chapter 2 of the County Code of Ordinances as Rules of Order for the 2020-2022 term of the County Board as proposed and submitted by the former Executive Committee. The motion was seconded by Supervisor Ziegelbauer and carried on unanimous voice vote of the board.

ELECTIONS

Chairperson Wegner announced that the next order of business would be the election of the County Board Chairperson. Chairperson Wegner, in accordance with Wis. Stat. § 59.12 directed Corporation Counsel to conduct the election of the Chairperson, Vice-Chairperson, and additional Executive Committee members. The elections were conducted by Corporation Counsel Crystal Fieber.

Department Heads Cory Roeseler, and Greg Schnell, and Executive Assistant Alayne Bosman were appointed as tellers.
