

**MINUTES OF COUNTY BOARD OF CANVASSERS
PARTISAN PRIMARY**

The Board of Canvass was called to order at 9:02 A.M. The meeting was posted on August 17, 2018 at 8:30 A.M. in compliance with the open meeting law. The Board canvassed the results of the August 14, 2018 Partisan Primary Election.
