JOURNAL OF THE MEETING OF THE SHEBOYGAN COUNTY BOARD OF SUPERVISORS

November 2, 2021

Pursuant to Wis. Stat. § 59.11, the November 2, 2021 session of the Sheboygan County Board was called to order by Chairperson Vern Koch at 6:00 p.m. Chairperson Koch noted that the notice of meeting was posted on October 29, 2021 at 3:00 p.m. in compliance with the open meeting law. The meeting opened with the Pledge of Allegiance by all present.

The roll call was taken and recorded with 24 Supervisors present; Absent: 1, Supervisor Ogea.

Supervisor Wegner moved for approval of the October 19, 2021 and October 26, 2021 Journals, which were distributed to all supervisors prior to the meeting. The motion was seconded by Supervisor Abler and carried on unanimous roll call vote of the board.

APPOINTMENTS

The Chairperson announced that the next order of business was the consideration of the appointments by the Chairperson.

LETTERS AND COMMUNICATIONS

The Clerk presented a copy of a letter from the Town of Herman Chairperson regarding the County redistricting plan. By Chairperson received for information.

The Clerk presented a copy of a letter from the Town of Sheboygan Falls Clerk regarding the County redistricting plan. By Chairperson received for information.

The Clerk presented a resolution from the Kenosha County Board of Supervisors pertaining to placement location process of Chapter 980 sexually violent persons. By Chairperson referred to the Law Committee.

COUNTY ADMINISTRATOR'S REPORT

County Administrator Adam Payne thanked and acknowledged County Clerk Jon Dolson and GIS Specialist Brett Zemba for their leadership and coordination developing the tentative nonpartisan county supervisory district plan. Mr. Payne spoke about the nation-wide opioid lawsuit settlement stage being considered in federal Court, and shared that the Wisconsin Counties Association will be providing a template resolution of support for all counties to consider. Due to the timing of the settlement discussions, this resolution will need to be considered for immediate action during the December County Board meeting. Mr. Payne concluded by thanking County Board Chairman Koch, Finance Committee Chairman Goehring, the County Board, Department Heads and all involved for their thoughtful approach and teamwork in helping craft the 2022 annual budget.

PUBLIC HEARING ON THE FINAL NONPARTISAN PLAN FOR COUNTY BOARD AND MUNICIPAL REDISTRICTING

Chairperson Koch noted that the Notice of Public Hearing was published on October 1, October 8, and October 15, 2021 and declared the public hearing on the final nonpartisan plan for County Board and Municipal redistricting open for anyone wishing to be heard.

There being no persons wishing to be heard, Chairperson Koch declared the public hearing closed at 6:10 p.m.

COMMITTEE REPORTS

The Clerk read the report of the Executive Committee regarding Resolution No. 25 (2021/22) Approving Use of American Rescue Plan Act (ARPA) Funds (No. 2) recommending adoption.

Supervisor Goehring moved to adopt the resolution. The motion was seconded by Supervisor Brauer and carried on unanimous roll call vote of the board.

The Clerk read the report of the Finance Committee regarding Resolution No. 26 (2021/22) Authorizing Participation in the Department of Natural Resources Municipal Dam Grant Program recommending adoption.

Supervisor Wegner moved to adopt the resolution. Supervisor Abler seconded the motion which carried on unanimous roll call vote of the board.

Supervisor Wegner moved to adopt the resolution. The motion was seconded by Supervisor Brauer and carried on unanimous roll call vote of the board.

Resolution No. 28 (2021/22) Re: Levying and Apportioning the Tax. Vice Chairperson Ziegelbauer announced that pursuant to County Code of Ordinances Section 5.06(a)(6) and (9) this document is before the board for immediate action.

Supervisor Goehring moved to adopt the resolution. Supervisor Te Stroete seconded the motion which carried on unanimous roll call vote of the board.

Ordinance No. 02 (2021/22) Re: Final Supervisory District Plan.

Earlier this month, at the Wisconsin Towns Association Annual Conference, I was made aware of an attempt to make last-minute changes to the County's redistricting plan, as communicated to the various County municipalities via County Resolution #21.

All towns have by now passed their own redistricting resolutions implementing the County's redistricting plan. In good faith we authored, passed, and properly noticed our resolutions prior to the date of October 19th, as specified in County Resolution #21. I submit to you that it is now too late to make changes that will require a number of towns to expend time and effort to author changed ordinances and complete the administrative requirements for public notice, passage and legal public notification.

Absent a compelling public need, directly impacting the rights of those we represent, I strongly and respectfully request the Sheboygan County Board approve the Tentative Redistricting Plan as presented to the municipalities as the permanent County Redistricting Plan.

Chairman Koch,

As part of the 2021 Non-Partisan Redistricting, the Town of Sheboygan Falls Town Board reviewed Sheboygan County's Resolution No.21 2021/2022 and unanimously supported the County's Tentative Supervisor District Plan by approving the Town of Sheboygan Falls Resolution #4 2021/2022 on October 4, 2021. Based on our updated population change the Board was able to keep the same Town Ward boundaries with populations between the 300-1000 target; with a few changes proposed for the County Supervisor Districts within our Town. Creating a third County Supervisor District within the Town of Sheboygan Falls would increase election costs by requiring more programming of equipment and more ballots. The Town of Sheboygan Falls already has 5 different ballot styles because of the existing school district / County Supervisor district combinations. Changes can also cause confusion for voters so keeping those changes to a minimum is important unless there is a dire need.

I respectfully request the County Board consider the time & effort all jurisdictions have already done in respect to the 2021 Redistricting process. I ask the County Board to adopt the Tentative Supervisor District Plan as presented in Resolution No. 21 2021/2022, supported by Town of Sheboygan Falls Resolution #4 2021/2022.

WHEREAS, the State of Wisconsin enacted Chapter 980 of the Wisconsin Criminal Code, "Sexually Violent Person Commitments" in 1994; and

WHEREAS, amendments were made to Wisconsin State Statute Chapter 980 in 2009, 2013, 2015, and 2017; and

WHEREAS, 2017 Act 184 provided for local oversight of sexually violent person placements by requiring counties be responsible for creating a temporary committee to prepare a report to identify an appropriate residential option for a sexually violent person on supervised release; and

WHEREAS, Wisconsin State Statute 980.08(4)(dm)(2) requires the county consult with a local law enforcement agency having jurisdiction over the residential placement option; and

WHEREAS, Wisconsin State Statute 980.08(4)(dm) does not require communication between the county and the local municipality where the proposed residential placement is located; and

WHEREAS, the term "adjacent property" is not clear in Wisconsin State Statutes in regards to properties that have only one location point in common; and

WHEREAS, the definition of "public park" is broad in Wisconsin State Statutes and may be open to differing court opinions; and

WHEREAS, the definition of "youth center" is silent on whether a private residence or boys or girls campground is considered a youth center; and

WHEREAS, government meetings must be open to the public and noticed so the public may attend;

NOW, THEREFORE, BE IT RESOLVED, the Kenosha County Board of Supervisors shall name the temporary committee created to prepare the report to identify an appropriate residential option for a sexually violent person on supervised release the "Chapter 980 Sexually Violent Persons Placement Review Committee"; and

BE IT FURTHER RESOLVED, the Chapter 980 Sexually Violent Persons Placement Review Committee's agenda shall be specific on the items it will discuss or act upon, and shall not be broad or vague on items it will discuss or act upon; and

BE IT FURTHER RESOLVED, the Chapter 980 Sexually Violent Persons Placement Review Committee's agenda and minutes shall be posted on the Kenosha County website in the "agenda center" in the same manner and location as other committee meetings are noticed; and

BE IT FURTHER RESOLVED, Kenosha County shall notify the municipal administrator and village president/town chairman within three business days after any employee, agency, or department is contacted by the State of Wisconsin about a potential placement location for a person under Chapter 980; and

BE IT FURTHER RESOLVED, the Chapter 980 Sexually Violent Persons Placement Review Committee shall notify the municipal administrator and village president/town chairman of the potential residence within three ten business days after a judge orders the county to finds a residence for a Chapter 980 placement; and

BE IT FURTHER RESOLVED, the employee, agency, or department researching the appropriateness of a residence shall collaborate with the municipal administrator and village president/town chairman in which the potential residence is located; and

BE IT FURTHER RESOLVED, Kenosha County shall enact a policy enabling municipalities to notify the county to add/modify municipal parks denoted on Kenosha County Interactive Mapping; and

BE IT FURTHER RESOLVED, Kenosha County shall enact a policy to enable municipalities to correct the zoning and Kenosha County Comprehensive Plan to denote municipal parks at no cost to the municipality; and

BE IT FURTHER RESOLVED, the Kenosha County Board of Supervisors requests the Wisconsin State Legislature to add an additional notice requirement to Chapter 980, requiring the State fund and provide written notice to any and all households within 1500 feet of the property in which a court places a Chapter 980 offender in, with said notice including the name, address and recent headshot of the offender, the sex-related crimes for which the offender being released has been convicted of, the restrictions placed on the offender, and how to report a violation of the restrictions placed on the offender; and

BE IT FURTHER RESOLVED, the Kenosha County Board of Supervisors requests the Wisconsin State Legislature clarify whether two properties that have only one location point in common are considered "adjacent property" in Wisconsin State Statutes; and

BE IT FURTHER RESOLVED, the Kenosha County Board of Supervisors requests the Wisconsin State Legislature clarify the definition of a "public park" in Wisconsin State Statutes; and

BE IT FURTHER RESOLVED, the Kenosha County Board of Supervisors requests the Wisconsin State Legislature revise the definition of a "Youth Center" to specify whether the definition of a "Youth Center" may include a private residence and boys and girls youth campgrounds or only includes licensed centers and facilities, such as a Boys & Girls Club, or a YMCA or YWCA; and

BE IT FURTHER RESOLVED, a copy of this resolution shall be forwarded to all municipalities located within Kenosha County, Kenosha County's Madison legislative delegation, all other Wisconsin counties, and the Wisconsin Counties Association.
