Both bids received well over budgeted amount of \$230,000. By delaying some items and having Building Services / Highway or associated entity pick up costs on others, estimated project costs total \$215,480. Moved by Glavan/seconded by Oppeneer to award project to Walt's Petroleum Service, Inc. at a cost of \$215,480; motion carried.

## DISCUSSION/ACTION UNIVERSITY OF WISCONSIN SHEBOYGAN MASTER PLAN ARCHITECT SELECTION

Three local architects submitted proposals (State to fund 50%). Following discussion, moved by Glavan/seconded by Oppeneer to contract with Bray Architects to provide updates for the Campus Master Plan at a cost not to exceed \$18,000; motion carried.
