- Consideration of County Board Referral Opinion of Corporation Counsel the letter from the North Central States Regional Council of Carpenters poses no threat to construction projects (a union vs. non-union issue) and no reason to deny awarding contractor contracts.
 Committee consensus filed document as received.
- Consideration Property Use Plan At its October 29, 2014 meeting, Finance Committee requested long-range plan for use of property at 502 North 6th Street if retained by County. Discussion focused on close proximity of property to County facilities and suggestions as outlined in memo drafted by TeBeest. Moved by Epping/seconded by Ziegelbauer to request Finance Committee retain property as approved by Property Committee at its October 21, 2014 meeting and for potential uses as outlined in memo; motion carried.
- Consideration of Department Projects Status Updates
 - ADRC Canopy/Vestibule should be complete before year-end.
 - Combined Dispatch Six to eight week lead-time on doorframes; anticipate end of December start date.
- Health & Human Services Lobby Addition delay due to window lead-time. TeBeest requested approval on two changes orders. Moved by Epping/seconded by Wheeler to approve four new "fire rated" doors to add panic hardware and replace existing ones in the stairwells at a cost of \$17,370.38; motion carried. Moved by Wheeler/seconded by Epping to

approve elevator shaft and associated ductwork inspection at a cost of \$6,425; motion carried. Brian Stout, University of Wisconsin Sheboygan noted permission granted to loan State artwork to Health & Human Services for new building addition.

- Rocky Knoll Break Room Installing drywall and mudding. Long lead-time on brick.
- Taylor Park Shelter Funding request of \$202,849 before County Board.
- University of Wisconsin Engineering Building All permits obtained, groundbreaking ceremony held, purchase orders written. Availability of cement questionable, which could delay project start; anticipate May completion date.

UW CAMPUS

- Consideration of 2014 Annual Night Safety Walkthrough Report Several things reported including burned out lights and broken sidewalks; already being addressed. UW System considering night guards, emergency phones in parking lot areas and potential parking fee. Epping suggested checking with Sheriff regarding additional security measures.
