April 19, 2016

Pursuant to Section 59.11 of the Wisconsin Statutes, the April 19, 2016 session of the Sheboygan County Board was called to order by Chairperson Roger L. Te Stroete at 6:00 p.m. Chairperson Te Stroete noted that the notice of meeting was posted on April 14, 2016 at 4:45 p.m. in compliance with the open meeting law.

Sheboygan County Sheriff's Department Honor Guard presented the colors and Chairperson Te Stroete led all present in reciting the Pledge of Allegiance.

The National Anthem was sung by Transportation Director Greg Schnell.

INTRODUCTION OF DEPARTMENT HEADS

Mr. Payne introduced the Department Heads and gave a brief description of the respective department responsibilities. A brief slide presentation was also shown of the book that was prepared and given to Chairperson Te Stroete at the April 12, 2016 county board meeting in appreciation for his thoughtful leadership.

MAIN MOTIONS (Adoption of Rules)

Supervisor Winkel moved to adopt Chapter 2 of the County Code of Ordinances as Rules of Order for the County Board as proposed and submitted by the former Executive Committee. The motion was seconded by Supervisor Marthenze.

Supervisor Baumgart moved to amend Section 2.12 by deleting the proposed additional verbiage in paragraph #1. Supervisor Uraynar seconded the motion which was defeated on roll call vote of the board of Ayes: 9, Supervisors Bauer, Baumgart, Conrardy, Damp, Glavan, Hoffmann, Ogea, Otten, and Uraynar; Noes: 16.

Chapter 2 of the County Code of Ordinances was adopted as proposed and submitted by the former Executive Committee as the Rules of Order for the 2016-2018 term on roll call vote of the board of Ayes: 22; Noes: 3, Supervisors Baumgart, Conrardy, and Uraynar.

ELECTIONS

Chairperson Te Stroete announced that the next order of business would be the election of the County Board Chairperson. Chairperson Te Stroete, in accordance with Wis. Stat. § 59.12 directed the County Clerk to direct the Corporation Counsel to conduct the election of the Chairperson, Vice-Chairperson, and additional Executive Committee members. The elections were conducted by Corporation Counsel Carl Buesing.

Department Heads Laura Henning-Lorenz, Wendy Charnon, and Aaron Brault were appointed as tellers.
