Re: Response to Resolution No. 03 (2018/19) – Supporting the Sheriff in Expanding Use of Electronic Monitoring to Alleviate Detention Center Space Shortage; Directing the Criminal Justice Advisory Committee to Study Alternatives to Incarceration; and Directing a Report on Long-Term Options to Address Detention Center Space Needs

In May of 2018, a resolution directed the Criminal Justice Advisory Committee to study alternatives to incarceration and provide a report on long-term options to address detention center space needs. In addition, the Sheriff, County Administrator, Health and Human Services Director, and Finance Director were also directed to assess the demands and trends involving the Detention Center and explore alternatives for improvement, and all have contributed to this report.

Background

As an overview, our current Detention Center was built in 1998 and we took occupancy of it in 1999. There are 290 beds at the facility. Industry standards recommend that the maximum population not exceed 85% capacity in order to be prepared for unknown jailing needs that can arise each day. Therefore, our Detention Center is considered to have 247 available beds.

The current jail that we utilize at our downtown facility has a capacity of 101 inmates. Industry standard would place the facility with 85 inmates.

Our current Juvenile Detention Facility has a capacity of 27 inmates. Industry standard would be 23 juveniles.

Throughout 2018, our daily population for adults was 330 to 360. These numbers exceed the recommended percentages and at times resulted in our staff having to triple bunk inmates

(sleeping on the floor utilizing a special cot and mattress). It also results in us having to reroute current bookings to the downtown facility because of lack of single bed space at the Detention Center.

Census

The inmates in our jail are classified as Minimum Security, Medium Security and Maximum Security. Within Maximum Security are additional classifications of High Risk and Special Needs. The industry standard of 85% is based on the need to be able to keep certain types of inmates housed separately or housed according to the different classifications. On March 4, 2019 our inmate population was as follows:

In breaking down the census we are able to determine that on average, **150 of our inmates are incarcerated as they await trial and are unable to post bond.** The average wait time for these inmates is 81.6 days. Another high number of our census relates to Probation Holds. We average around 60 individuals who are on probation and waiting for revocation or serving out a probation sanction. The average stay for these inmates is 44.3 days. For the Probation Holds, the State does provide some revenue relief. For 2018, the State relief was approximately 57% of the total inmate cost incurred.

The remaining inmates have such a vast amount of varying charges that it is hard to break down the average stay. Additionally, each day the list changes with those booked, released and moved to prison. Included is an attachment for January 7, 2019 that includes everyone who is currently in our system and the charges against them.

Current Alternatives to Incarceration

The current alternatives to incarceration being utilized by Sheboygan County are:

- Huber Law Program
- GPS monitoring
- Day Reporting
- Veterans Court
- Drug Court

Huber Law Program

This program allows inmates to leave jail to go to work for up to 12 hours a day. They must return to the Sheboygan County Jail or Detention Center each day after work. These inmates are not monitored during the times they are not at the jail or detention center. The average daily in-house Huber population in 2018 was 59. In 2017, it was 71 and in 2016 it was 54. The cost per day for the Huber inmates is \$66.51. In 2018, cost for the Huber inmates was \$1.4 million. Cost of staff overseeing this program was \$91,461. There is no State support for this program.

GPS Monitoring Program (associated with the Huber Law Program)

This program utilizes GPS monitoring bracelets. Inmates are monitored by GPS and reside at their current residence. They are restricted to house arrest except during work hours, employment search or child care. Currently, the average number of inmates on GPS monitoring is 60. The average daily GPS monitoring population in 2018 was 47, 49 in 2017, and 35 in 2016. The County pays \$3.95 per day to rent a monitoring bracelet. Inmates pay \$23.00 a day for use of a GPS monitoring bracelet. In 2018, cost of staff overseeing this program was \$109,714.

Day Reporting Program (Pre-Sentencing Program)

Our Day Reporting Program is relatively new and began in February, 2014. This program will consist of some individuals being on a GPS bracelet, and in some instances, required to self-monitor with a Soberlink breathalyzer unit. Not all individuals are on an electronic type of device and they report to the Detention Center on a daily basis. Cost to the County to rent the Soberlink is \$6.00 per day and those on the GPS monitoring bracelet costs the County \$3.95 per day. In 2018, cost of staff overseeing this program was \$166,951.

Sheboygan County's Day Reporting Program is intended to lower the number of inmates incarcerated and awaiting trial. In exchange for reporting face-to-face at the Detention Center, the individuals would not have to post a cash bond, thus lowering the number of individuals requiring jail space. The initial plan for the program was to monitor around 20 individuals daily with 4 staff members. (This initially included Community Service monitoring). As of January 2019, there are 221 day reporters in the program. Of these, 123 were on some form of electronic monitoring.

Veteran's Court Program

The Veteran's Court Program was established in August, 2012 to assist veterans who were arrested for certain crimes and to resolve the outcome by either reducing sentences or deferring prosecution. There is criterion of having a treatable/diagnosable illness, for example, drug dependency or PTSD. Judge Sutkiewicz presides over these cases and the program sees around 15 veterans on an average monthly basis. There have been 27 successful cases adjudicated by using this program and reducing bed space in our facility. Since inception, the program has had 27 individuals graduate.

Drug Court Program

The Drug Court Program was established in September of 2016 and is similar to the Veteran's Court. It focuses on those with drug dependencies and tries to reduce or defer sentences as a result of intensive drug treatment programs. Judge Stengel oversaw this program for many years until 2018. Judge Hoffmann is now the presiding judge over the program. The program averages 10 to 20 participants on a daily basis. This program is very challenging with a very low graduation rate. Since inception, the program has had 6 individuals graduate.

Both the Veterans and Drug Court Programs require significant staff time from all different areas within our system. Drug Court meets weekly on Thursdays. It usually meets for two hours and consists of a Circuit Court Judge, Sheboygan Police Chief, a member of Probation and Parole, Sheriff's Bailiff, representative from the Public Defender's Office and several representatives from Health and Human Services (counselors).

Other Alternatives to Incarceration

Some additional alternative programs that exist which are not currently being utilized by Sheboygan County are:

- Domestic Abuse Court Program
- Operating after Revocation Court Program
- Mental Health Courts

Domestic Abuse Courts

District Attorney Joel Urmanski is currently looking into the feasibility of additional programs related to Domestic Abuse Courts. The impact for the number of bed space utilized by Domestic Abuse offenses is relatively low.

Operating after Revocation Courts

The Operating after Revocation (OAR) Courts were popular in previous years; however, with recent changes to the law and decriminalizing more OAR offenses, the need for this type of program would not be necessary. We house very few individuals for any type of license offenses. During this month, we have not had anyone in custody sentenced specifically for OAR. Several years ago when OAR Courts were popular, there were a lot more issues with having to incarcerate these types of violators.

Mental Health Courts

Although CJAC did not review this alternative in-depth, the Mental Health Courts have seen some success. The Bureau of Justice Assistance (BJA) administers a Mental Health Court Program. This program funds projects that seek to mobilize communities to implement innovative, collaborative efforts that bring system wide improvements to the way the needs of adult offenders with mental disabilities or illnesses are addressed. Mental Health Courts are an extremely recent phenomenon. While they appear to be a promising strategy to reduce the involvement of people with mental illness in the criminal justice system, very little research is available on their effectiveness in general, or how different community variables affect outcomes for the courts.

Recommendations

- Expand the use of electronic monitoring and day reporting
- Increase staffing for the current Alternatives to Incarceration Unit
- Continue assessing current practices and exploring alternatives to incarceration to reduce the average jail and detention center daily population
- Hire a consultant to complete a Detention Center Study that assesses our current facilities, pretrial processes, alternatives to incarceration, treatment programming alternatives, Detention Center expansion options, and the cost benefit associated

Increase staffing for current Alternatives to Incarceration Unit (AIU)

The current Huber Facility is still in operation. It will remain in operation until such time as the Sheriff determines the need to close it and utilize the space for secure inmates. Currently, the Huber Facility is not full; however, secure inmates are not housed with Huber Law inmates for security and classification reasons. The designated Huber Law Center space would be beyond its capacity if we did not utilize the GPS Monitoring and Day Reporting Programs.

The original vision for the AIU was to supervise approximately 50 Huber law inmates on a daily basis that were both in the facility and on GPS monitoring. They were also expected to supervise up to 20 Day Reporting Program inmates.

At present, the AIU is overseeing approximately 286 people. Of these, 182 inmates are on Day Reporting, 57 are under Huber, and 47 are on GPS monitoring. The AIU supervises all of these programs, and also participates in the Veteran's Court and Drug Court. Recently, the lack of resources has required the program to pull back from helping inmates with finding jobs or enrolling in school. Essentially, the AIU has stopped doing any type of rehabilitation work, and has suffered with limited one-on-one contact with the inmates.

It is recommended to increase the staffing for the AIU in order to expand their capability and reinstate more of the rehabilitation support. The staffing model would be to hire 2 additional full time Corrections Officers at an annual cost, including benefits, of \$137,016. The Sheriff also believes this would be necessary and sufficient to support closing the Huber Law Center.

Hire a Consultant for In-Depth Analysis

As we discussed alternatives to incarceration to help aid in the lowering of the Daily Population in our Jail system, we discovered limitations in our ability to gather more in-depth analysis of the different trends in justice facilities. The traditional facility is changing with the rise in electronic supervision, work release and similar programs. Could our existing facilities be renovated to meet the changing demographic of our incarcerations? Do we want to look for better ways to address the drug addiction and mental health needs in our incarcerated population? What alternative trends have been working better than others? Is our only option expansion of the Detention Center?

We can see by our inmate population that the increases started for us in 2016 and have not shown signs of decreasing. From 2005 through 2015, the daily population in our jail system would move from slightly below 200 inmates to as high as 318 inmates. In June of 2016, the daily population started to steadily increase from 302 inmates to 336 inmates by the end of year. 2017 never went below 344 inmates and 2018 never went below 366 inmates.

The construction of Phase III is in the current 5-year Capital Funding Budget. The current estimate is \$18.8 million for the addition, and \$1.8 million for operational costs using a staffing model that would involve closing the Law Enforcement Center. To initiate such an expansion, it is prudent to hire a consultant to provide an in-depth study of our current facility and operations, along with alternatives to incarceration that are succeeding in the justice system. The Sheboygan County Board's Executive, Finance and Law Committees support hiring a consultant, and the County Administrator, working in collaboration with the Sheriff and Finance Director, recently convened a Detention Center Study Oversight Committee.

The Detention Center Study Oversight Committee members consist of the following County Board Supervisors and staff: County Board Chairman Tom Wegner, County Board Vice-Chairman and Law Committee representative Vern Koch, Finance Committee representative Bill Goehring, and Health and Human Services Committee representative Roger Otten. Staff will include County Administrator Adam Payne, Sheriff Cory Roeseler, Inspector Chad Broeren, Correctional Administrator Paul Brinkman, Assistant Correctional Administrator Pat Bricco, Finance Director Wendy Charnon, Health and Human Services Director Matt Strittmater, Behavioral Health Manager Jackie Moglowsky, Lead Health Strategist Libby Holte, and Executive Assistant to the County Administrator Alayne Bosman.

The Detention Center Study Oversight Committee is currently developing a list of study objectives, as well as gathering information from other counties. Request for proposals will be sought and we hope to select and hire a consultant this summer. The Criminal Justice Advisory Committee and County Board will continue to be engaged in order to garner key input and support as we work together in collaboration to problem-solve.

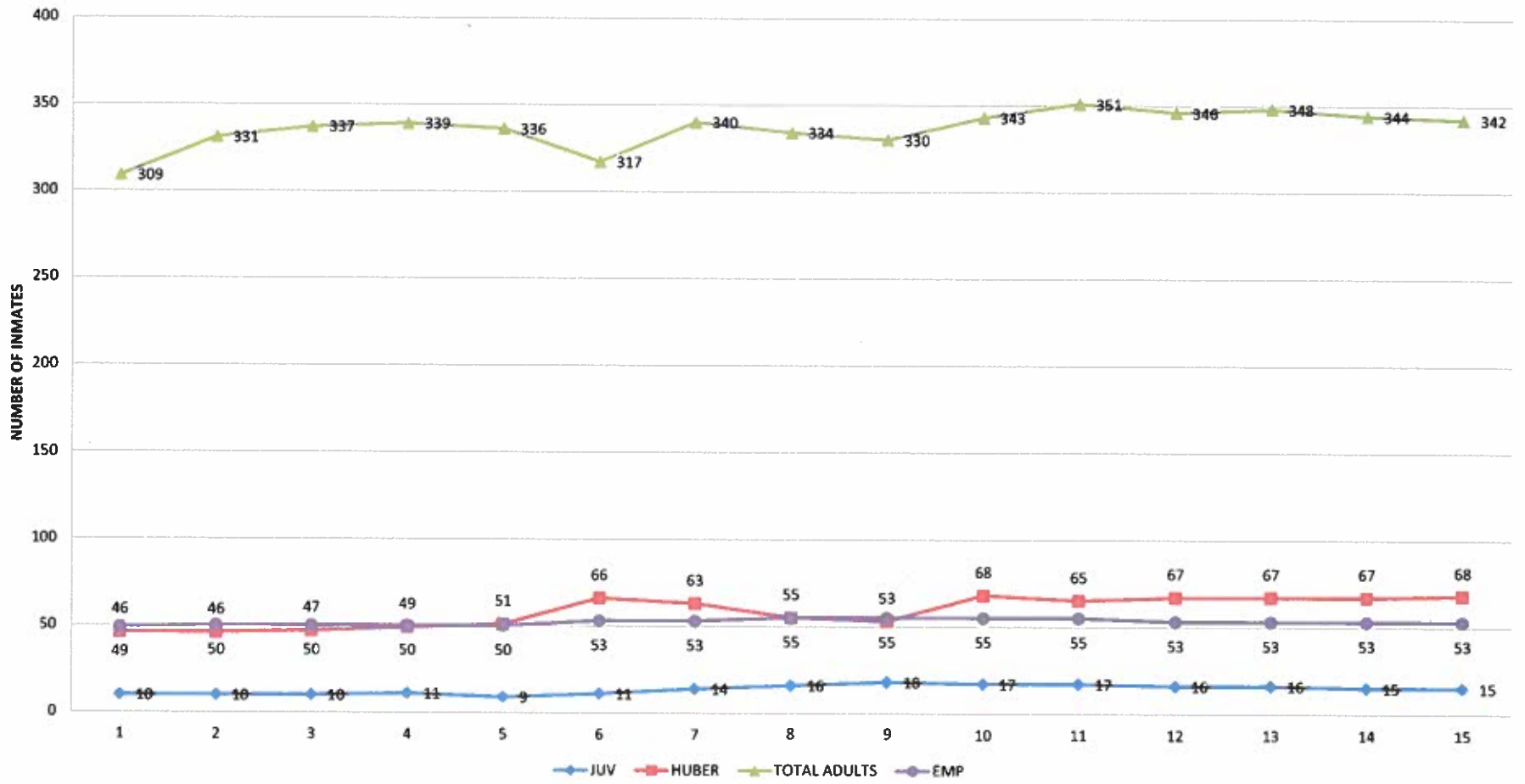
