REVIEW AND APPROVE MINUTES: October 4, 2011 Health and Human Services Committee Meeting

Tom Eggebrecht thanked Corporation Counsel Carl Buesing for attending today's meeting.

Tom Eggebrecht informed the Committee that in their packets is an agenda for the Friday, October 21, 2011 Wisconsin County Human Service Association Eastern Region meeting.

Tom Eggebrecht informed the Committee that in their packets is a letter from the Centers for Medicare and Medicaid Services which was written in response to a letter written by Tom and Supervisor Feider expressing Sheboygan County's concerns with the proposed changes to Wisconsin's Family Care Program. Tom informed the Committee that he also received a follow-up letter from the Centers for Medicare and Medicaid Services indicating State waiver amendments have been submitted to the Centers for Medicare and Medicaid Services.

Tom Eggebrecht informed the Committee that Elizabeth Mahloch will be recognized at this evening's County Board meeting for her receipt of the *Friend in County Government Award*, the Wisconsin Counties Association's highest honor in going above and beyond the call of duty during State budget deliberations on the issue of income maintenance.

CONSIDERATION OF ORDINANCE ON REGULATING FIREARMS IN COUNTY BUILDINGS – Corporation Counsel Carl Buesing

Corporation Counsel Carl Buesing provided an overview of the current draft of the ordinance Re: Regulating Firearms in County Buildings. It was the consensus of the Committee to take no action on the Ordinance at this time.

REPORT ON STATE PLAN FOR MEDICAID COST CONTAINMENT - Thomas Eggebrecht

Tom Eggebrecht presented a PowerPoint presentation on the State of Wisconsin Department of Health Services' plan on Medicaid efficiencies and cost-savings initiatives recently released by the Department of Health Services for 2011-2013. The Department of Health Services is proposing a \$550 million savings on the efficiencies and cost-savings initiatives. Tom's PowerPoint focused on the following areas: Eligibility Reform, Managed Care Reform, Claiming Reform, Payment Reform, and Fraud and Audit Reform. Other focus areas proposed are: expanding Birth to Three services under a State amendment; convert Community Recovery Services to an alternate plan; and maximize drug rebate collections.

The next steps include public hearings and Federal approval.
