## **REVIEW AND APPROVE MINUTES: August 30, 2011**

# REVIEW OF THE FINAL EMERGENCY PROTECTIVE PLACEMENT RESOURCE PLAN -- Michael J. Taubenheim

Mr. Taubenheim distributed an update of the Action Plan for the Final Emergency Protective Placement Resource Plan. Since our plan, Rocky Knoll has already had one placement occur where we have accepted the admission of a known individual to both our departments, who has occupied Rocky Knoll rooms on several occasions prior and has also worked with the Health & Human Services Department. This person was brought to St. Nicholas Hospital under a medical need, but upon admission, was determined to be incompetent and needed to be cared for in a long term nursing home. Therefore, this initial contact was made through the normal discharge process which caused some confusion between the two departments which was resolved. This is a perfect example of the Emergency Protective Placement Program as there is no other place that can take this type of individual. Mr. Taubenheim met with Mr. Eggebrecht to clarify and refine some of the procedures to be used going forward to better handle these situations.

Mr. Taubenheim and Mr. Eggebrecht had a follow up meeting to explore moving forward to meet with Aurora to formally roll out the program with them. It has been determined that the amount of users would be about 6-12 people to be placed per year. Mr. Taubenheim indicated that this was a positive learning experience for Rocky Knoll to meet with Health & Human Services on this project and Mr. Eggebrecht confirmed that it was a positive experience for Health & Human Services.

It was further discussed that the Emergency Protective Placement Resource Plan is to be presented to the County Board.
