Request to order 2019 squads in 2018

We learned recently from City/County Purchasing Agent Bernie Rammer that the deadline for ordering 2019 Ford Interceptor squads in September 21, 2018. This is due to Ford making design changes for a 2020 model year Interceptor that will begin production in early 2019. This updated design will come with an increase in price.

If we place our order prior to the 2018 deadline we are able to purchase at 2018 prices and avoid having to purchase any new equipment for the interior of the squads as our current equipment will fit the current design.

While we do not know the extent of a price increase or equipment compatibility, the potential savings by ordering early would likely be at least \$2000-\$3000 per unit for a total savings of \$14,000-\$21,000.
