Coroner

Motion by Koch, second by Uraynar, directing Attorney Buesing to draft an ordinance for the following: increase cremation fee from \$100 to \$150, keep disinterment fee at \$100 and increase death certificate fee from \$0 to \$50. This motion also includes the corresponding reduction in property tax levy and forwarding the ordinance to the County Clerk's Office so it will be added to a County Board agenda. Motion carried.

Discussion was held on the future organization of the Coroner's Department. Chairman Epping asked Attorney Buesing to create a draft of an ordinance for a medical examiner for the Law Committee to review. Chairman Epping requested the appropriate people reach out to the medical examiner in Brown County reference attending a future Law Committee meeting.

Sheriff's Department

Discussion was held with Todd Niels and Keith Enstrom from the Plymouth Ambulance Board. The discussion was in reference to research they are conducting to create a business model for

Plymouth Ambulance. They will contact Emergency Management Director Steve Steinhardt with further questions.

Resolutions or Ordinances Referred by County Board

Motion by Koch, second by Epping, to request additional time to review Ordinance No. 06 – Establishing Speed Zones on County Road “C” (Town of Plymouth) due to being shorthanded at the meeting and to get additional information from the Highway Department. Motion carried.
