MINUTES OF COUNTY BOARD OF CANVASSERS RECOUNT OF THE PRESIDENTIAL ELECTION HELD ON NOVEMBER 8, 2016

DATE OF CANVASS:

December 1 through December 6, 2016

BOARD MEMBERS:

Jon Dolson, County Clerk Anita Klein, Democrat Party Daniel Jones, Republican Party

ALSO PRESENT:

Jeannie Binsfeld, Deputy Clerk, Corporation Counsel Carl Buesing, Asst. Corporation Counsel Crystal Fieber, tabulators, and numerous observers from political parties and the press.

The Board of Canvass was called to order at 9:06 A.M. on December 1, 2016. The meeting was posted on November 29, 2016 at 6:15 P.M. in compliance with the open meeting law. The Board oversaw the recount of the 2016 presidential election.

The Canvass was conducted as follows:

County Clerk Dolson read names of the tabulators chosen to perform the recount. Due to the last minute nature of the recount, there was some miscommunication between the Clerk's office and volunteers who were not selected to participate in the recount effort.

County Clerk Dolson explained the recount process. Attorney Buesing offered further explanation of the process, as well as legal aspects.

Official representative of the candidate's campaigns were noted as: Paul Gruber – Donald Trump and Nanette Bulebosh – Hilary Clinton.

After Board discussion regarding write-in votes, Clerk Dolson moved to count scattering as a whole. Seconded by Board Member Jones. Motion carried.

Board member Klein moved to count ballots by hand. Seconded by Board Member Jones, Motion carried.

The first four municipality's ballots were transported to the counting room at 9:45 a.m. The recount commenced.

The following discrepancies were noted:

Town of Greenbush - Machine totals were verified.

Town of Herman - Machine totals were verified.

Town of Holland – Machine totals were verified.

Town of Lima –After all ballots were counted three times there were five extra votes for Donald Trump. Board member Klein moved not to count again and to accept the total. Clerk Dolson seconded. Motion carried.

Town of Lyndon - Machine totals were verified.

Town of Mitchell - Machine totals were verified.

Town of Mosel - Machine totals were verified.

Town of Plymouth – Machine totals were verified.

The recount recessed for the evening at 4:15 P.M. The recount reconvened at 8:45 A.M. on December 5, 2016

City of Sheboygan --

Wards 1 and 4 -

Ward 1 - Machine totals were verified.

Ward 4 - Machine totals were verified.

Wards 2, 3, 11 and 12 -

Ward 2 - Machine totals were verified.

County Board Chairman Wegner and County Administrator Payne entered the recount room to observe. Both addressed the tabulators briefly.

Ward 8 – After all ballots had been counted, there was a difference of twelve ballots from what had been entered on the inspectors statement. The number of voters matched the number of ballots counted. According to the inspectors statement there were 3 large ballot jams. The ballots had been pulled from the machine and dropped in the bin. Clerk Dolson moved to accept the ballot total. Seconded by Board Member Jones. Motion carried.

Ward 9 - Machine totals were verified.

Three ballots were returned via email and were run through the machine as plain paper, not on a remade ballot as they should have been, therefore the machine did not tabulate the ballots. Another voter was given two numbers but one ballot, which accounts for the fourth ballot. Board member Klein moved to count the three emailed ballots and add the votes to the totals. Clerk Dolson seconded. Motion carried.

The recount recessed for the evening at 5:30 P.M.

The recount reconvened at 8:45 A.M. on December 6, 2016
