Mr. Scheuerman was elected Vice-Chairperson for the next year.

Chairperson Pfaller requested nominations for Secretary. Mr. Moehring made a motion to nominate Eugene Blindauer for Secretary. Motion seconded by Mr. Frederick. Roll call vote: Moehring – yes; Stodolka – yes; Frederick – yes; Pfaller- yes; Blindauer – yes. Motion carried. Eugene Blindauer was elected Secretary for the next year.
