The meeting was called to order by Chairperson Koch at 3:02 PM. It was noted that the agenda was posted on October 21, 2022, at 9 AM in compliance with the Wisconsin Open Meeting Law. A motion was made by Te Stroete and seconded by Dulmes to approve the minutes as submitted. Motion carried. There was no correspondence to the committee.

Consideration of Loan Request – KH & KS PROPERTIES, LLC

York presented the project summary to the committee and the loan request being proposed by the company to purchase and renovate a downtown Plymouth building located at 435 E Mills Street. The business currently leases a portion of the office building. The company provided a summary of their plans for the building, which included building purchase, building renovation, making the building ADA compliant and repair to the parking lot. Staff presented the proposed terms of the project and business operations.

A motion was made Mr. Dulmes and seconded by Mr. Hammond to move into closed session for the purpose of negotiations and use of public dollars.

Upon returning from closed session, on a motion made by Mr. Dulmes approve a One hundred thirty-five thousand and 00/100 (\$135,000.00) loan to KH & KS Properties for a term of five years with an interest rate of 3%. The first six months of the loan will be interest only payments. In consideration for this loan, the committee required that the Mr. Stifle and Ms. George provide life insurance in the amount of the loan to be additionally insured when the required SBA life insurance is implemented. The committee sought personal and corporate guarantees and general business security interest. The motion was seconded by Mr. Brinkley. Motion carried.

Being no other business, a motion was made by Supervisor Te Stroete and seconded by Mr. Hammond to adjourn the meeting. Motion carried.
