Review and Approve changes in the standard fire department radio template:

The subcommittee decided that Sheb. FD Secondary will be added to the template, Memorial Hospital talk group will be removed and replaced with Aurora Sheboygan County.

Discussion and Action on Mt. Calvary FD & Ambulance request to add Sheboygan County Talk Groups:

After discussion, Brungraber made motion to allow access to County Fire Primary, Secondary and Fire/EMS talk groups. Second by Steinhardt. Motion carried unanimously.

Discussion and Action on State of WI – Department of Revenue request to add Sheboygan County Talk Groups:

After discussion, Motion by Steinhardt to Allow WI – Department of Revenue access to Sheriff Primary, Secondary, Law Channels, Event Channels and SPD Primary. Second by Brungraber. Motion carried unanimously.

Discussion and Action on Manitowoc PD's K-9 request to add Sheboygan County Talk Groups:
After discussion, Motion by Brungraber to Allow Manitowoc PD access to Sheriff Primary, Secondary, Law Channels, Event Channels and SPD Primary and Secondary. Second by Greenwood. Motion carried unanimously.

Discussion and Action on Marc2 / Sheboygan LZ Channel:
Brungraber reported that all Air Ambulances would use ITAC GRY and ITAC Black as the backup. The Discussion is tabled until the next meeting, when Umble & Greenwood could provide an update on how soon the change can take place.
