July 21, 2026

Pursuant to Wis. Stat. § 59.11, the July 21, 2026 session of the Sheboygan County Board was called to order by Chairperson Keith Abler at 6:00 p.m. Chairperson Abler noted that the notice of meeting was posted on July 17, 2026 at 3:30 p.m. in compliance with the open meeting law. The meeting opened with the Pledge of Allegiance by all present.

The roll call was taken and recorded with 25 Supervisors present, 1 Supervisor attended remotely: Supervisor Liebau.
