Chairman Jacqueline Veldman called the meeting to order at 9:00 a.m.

Chairman Veldman certified compliance with the open meeting law. The notice was posted at 1:00 p.m. July 31, 2026.

Supervisor Vander Weele made a motion and Supervisor Wegner seconded the motion to approve the minutes from July 6, 2026. Motion carried.

Supervisor Kuhlow made a motion and Supervisor Wegner seconded the motion to approve the vouchers. Motion carried.

Supervisor Wegner made a motion and Supervisor Vander Weele seconded the motion to approve Supervisor Kuhlow's attendance at the Wisconsin County Highway Association (WCHA) Executive Board Meetings on July 13, 2026 and August 10, 2026, the WCHA Board of Director's meetings on July 27, 2026 and August 24, 2026, and a WCHA / Wisconsin Department of Transportation quarterly meeting on August 26, 2026. Motion carried.

Supervisor Wegner made a motion and Supervisor Vander Weele seconded the motion to approve Chairman Veldman's attendance at the Transportation Department's budget meeting on September 9, 2026. Motion carried.

Members of the Wisconsin Department of Transportation Northeast Region Leadership discussed construction, maintenance, budgets and future projects planned for the state highways in Sheboygan County.

Transportation Director Bryan Olson updated the committee on current activities at the Sheboygan County Memorial International Airport.

Supervisor Wegner made a motion and Supervisor Vander Weele seconded the motion to approve the New Individual Aircraft Hangar Lease with John R Johnston for Hangar 2, N6187 Resource Drive, Sheboygan Falls. Motion carried.

Supervisor Wegner made a motion and Supervisor Kuhlow seconded the motion to approve the New Individual Aircraft Hangar Lease with Brian McClaren for Hangar 2, N6187 Resource Drive, Sheboygan Falls. Motion carried.

Discussion about Safety Improvements to the Intersection of County Road PP and Highland Drive. Olson said that a traffic study will be done this fall and he will report back to the committee.

Supervisor Wegner made a motion and Supervisor Vander Weele seconded the motion to approve Several Traffic Control Modifications within the Village of Random Lake. The first modification is to convert the current three-way stop intersection at 1st Street and Butler Street into a four-way stop intersection. The second modification is the removal of the southbound stop sign on Allen Street at the intersection of Allen and Spring Street, making Allen Street a through street for northbound and southbound traffic. The third modification is installing an additional stop sign at southbound Spring Street, creating a three-way stop at the intersection of Western Avenue & North Spring Street. Motion carried.

Supervisor Vander Weele made a motion and Supervisor Wegner seconded the motion to approve the Emergency LTE – Highway position. Motion carried.

Supervisor Vander Weele made a motion and Supervisor Kuhlow seconded the motion to approve Sheboygan County Resolution No. ____ (2026/27) Re: Authorizing County Aid for Culvert and Bridge Construction in the Towns of Holland, Plymouth, and Sheboygan. Motion carried.

Supervisor Wegner made a motion and Supervisor Vander Weele seconded the motion to approve the Transportation Budget – Airport Division. Motion carried.

Supervisor Kuhlow made a motion and Supervisor Vander Weele seconded the motion to approve the Transportation Budget – Lake Breeze Aviation. Motion carried.

Supervisor Wegner made a motion and Supervisor Vander Weele seconded the motion to approve the Transportation Budget – Highway. Motion carried.

Supervisor Vander Weele made a motion and Supervisor Kuhlow seconded the motion to approve the Transportation Budget – Transportation. Motion carried.
