## MINUTES OF COUNTY BOARD OF CANVASSERS PARTISAN PRIMARY ELECTION

The Board of Canvass was called to order at 9:06 A.M. The meeting was posted on August 11, 2022 at 8:30 A.M. in compliance with the open meeting law. The Board canvassed the results of the August 9, 2022 Partisan Primary Election.

The Canvass was conducted as follows:

County Clerk Dolson reviewed the canvass process with the Board of Canvass.

The number of voters and number of ballots cast were verified (the highest number was identified and marked prior to the meeting). Some discrepancies were noted. Explanation of discrepancies and resolution follows by municipality.

Inspector Statements were reviewed for signatures and security seal verification.

Candidate totals were verified with original printouts from Election Night.

The following discrepancies were noted: (scattering = write-in vote)

**Town of Herman** – Rep. Congress District 6 Democratic, +1 scattering. Inspector Statement missing ballot bag red seal number

Town of Holland - No discrepancies were noted

**Town of Lima** – Error in reading tape. 6's were mistakenly read as 8's resulting in the following corrections-Governor Democratic, Evers, -2; Secretary of State Democratic, La Follette, -20; Governor Republican, Fischer, -2; State Senator District 9 Republican, Villareal, -2

**Town of Lyndon** – State Treasurer Democratic, scattering +1; Rep. in Congress District 6 Democratic, scattering, +2; State Senator District 9 Democratic, scattering +2; Sheriff Democratic, scattering +2; Clerk of Circuit Court Democratic, scattering +2; Governor Republican, scattering +1; Sheriff Republican, scattering +2; Clerk of Circuit Court Republican, scattering +1; Attorney General Libertarian, scattering +1

**Town of Wilson –** State Senator District 6 Democratic, Schroeder +5, and scattering -5. Green Chain of Custody form not signed by municipal clerk when opened at public test.

Village of Adell - U. S. Senator Republican, scattering -1; Clerk of Circuit Court Republican, scattering +1

Village of Cascade – Lt. Governor Democratic, scattering +1. In error, county races were not entered on election night resulting in Sheriff Republican +134, and scattering +1; Clerk of Circuit Court Republican +113, and scattering +1. Inspector Statement missing red ballot bag seal number.

Village of Oostburg – Lt. Governor Democratic, scattering -2, State Senator District 9, Democratic, scattering -2; Sheriff Democratic, scattering +1; Clerk of Circuit Court Democratic, -1

Village of Random Lake – State Senator District 9 Democratic, Schroeder +2, and scattering -2; State Treasurer Republican, Leiber +10; Rep. to Assembly District 26 Republican, scattering +2. Did not place manila envelope containing used seals in the ballot bag.

Village of Waldo - Red security pouch not sealed. Blue security seal missing.

City of Plymouth - State Senator District 9 Democratic, Schroeder +3, and scattering -3.

City of Sheboygan –Undetermined as to which wards/polls did not place manila envelope containing used seals in ballot bag(s). Polls 3,6,9 and 10 Green Chain of Custody form not completed with signatures of three inspectors. Polls 3, 7 and 10 need to record new seal number on Green Chain of Custody if seal number is changed on red security pouch.

## City of Sheboygan Falls - No discrepancies were noted

Election results were certified by the Board of Canvass. Board members Anthony Fessler and Christine Smith declined per diem or mileage.

The Board of Canvass adjourned at 3:45 P.M. This concluded the Canvass of the August 9, 2022 Partisan Primary Election.

## General Notes/Reminders to ALL:

Inspector Statements should never be blank, though several were. It's extremely important that election inspectors make it a habit of hourly **reconciling throughout the day**, even when the day is slow.

In order to have a **continuous tape** from opening of polls to closing of polls the Zero Report, when polls are opened should not be torn off. **THREE signatures** are <u>required</u> at the opening <u>and</u> closing of polls.

Chief Inspectors are in charge on election day. Municipal clerks should never take on that responsibility, but should be available to answer questions, provide supplies, and support.

Poll workers should not discourage voters from using the Clear Access machine.

The large absentee envelopes in the supply box (pink, white & manila) can be recycled and not wasted if they haven't been written on. We ask that <u>poll workers complete ONLY the envelopes that will be returned.</u>

Unused ballots **should not** be returned to the County Clerk's Office. They can be destroyed at your municipality.
