Planning & Conservation-

Consideration of 2023 Stewardship Applications. Mr. Betry presented the Stewardship Application Requests ranked, noting that there were more requests than funding available. Staff & the Sheboygan County Recreational Management Advisory Committee (SCRFMAC) recommendations for funding were made following the model from previous years. Comments and questions were taken for the projects as Chairperson Abler conducted voting on each application individually:

- Sheboygan County Cycling. Supervisor Henry Nelson motioned to approve the recommended funding. Motion seconded by Mr. Lammers. Motion carries with no opposition.
- Cascade Mill Pond. Supervisor John Nelson motioned to approve the recommended funding. Motion seconded by Supervisor Gruber. Motion carries with no opposition.
- Bookworm Gardens. Supervisor Gruber motioned to approve the recommended funding. Motion seconded by Mr. Lammers. Motion carries with no opposition.

- Glacial Lakes Conservancy. Supervisor John Nelson motioned to approve the recommended funding. Motion seconded by Supervisor Henry Nelson. Motion carries with no opposition.
- Nutt Hill Masterplan. Supervisor Gruber motioned to approve the recommended funding. Motion seconded by Mr. Lammers. Motion carries with no opposition.

Consideration of Use of Campground Non-Lapsing Account Funds. Mr. Brault requested to use \$3,000 in funds to update the foot golf course at the Marsh. Mr. Lammers motioned to approve. Motion seconded by Supervisor John Nelson.

Update on Brownfield Grant Award. Mr. Brault notified the committee that the department was successful in their recent EPA Brownfields Grant. We have submitted the work plan and are looking for an environmental consultant to help with the project.

Other Department Project and Program Management Updates- Mr. Brault informed the committee that the department has found someone to replace Kevin Stange as he is retiring at the end of the month. There will be two weeks of overlap to help train the new hire.
