Property Committee – Regular Meeting, June 11, 2024 at 5:00pm – Moved by Supervisor Nelson, seconded by Supervisor Smith to approve minutes as presented; motion carried with no nay votes.

CORRESPONDENCE

Lease Amendments with Bookworm Gardens & UWGB – Director Dulmes shared that Corp Council is working on a lease amendment to release an area of land from UWGB to Bookworm Gardens to continue with their design of an expansion. Additionally, another amendment is being created to remove the Physical Education & Fine Arts Buildings from the current lease, as they are both under-utilized. This would allow the County to sublease these facilities to another entity that would meet the deed restrictions, and would be dedicated to investing in the facilities.

BUILDING SERVICES

- Consideration of Parking Lot Use at Health & Human Services Partners for Community
 Development is requesting to once again use the parking lot at Health & Human Services to
 host a Trunk-or-Treat event on Saturday, October 26, 2024 as part of their National
 Weatherization Day event. Moved by Supervisor Jorgensen, seconded by Supervisor Nelson
 to approve the request as presented; motion carried with no nay votes.
- Consideration of Promotion Director Dulmes explained that Table of Organization changes were approved earlier this year that would be effective January 1, 2025. Part of those changes were adding a second HVAC Technician. He explained that a current employee already has the required training and certification for this position, and he would like to promote this employee now, rather than waiting until January. Moved by Supervisor Smith,

seconded by Supervisor Nelson to approve the promotion request; motion carried with no nay votes.

- Consideration of Contingency Requests for Detention Center Electrical The security gate
 at the Detention Center, which allows access to the back, was hit several years ago. The
 gate has not operated properly since, and now parts are becoming obsolete. Director Dulmes
 requested to move \$60,000 from Contingency to Detention Center Electrical to replace the
 gate. Moved by Supervisor Nelson, seconded by Supervisor Jorgensen to approve the
 request as presented; motion carried with no nay votes.
- Consideration of 5 Year Capital Plan Capital Project Funding Requests Director Dulmes presented each project and explained each with his suggested prioritization level, as follows:
 - County Wide Door Access Control Replacement (2025 Transportation, Airport, Admin & Rocky Knoll, 2026 Courthouse, Aging & Disability Resource Center, Health & Human Services, Law Enforcement Center, Detention Center & UWGB) \$900,000
 - 2. Courthouse Tuckpointing & Window Replacement (2024 & 2025) \$5,911,591
 - 3. Roof Replacements (2025 UWGB & Courthouse Annex Railings, 2026 Courthouse top floor recoat & 2nd floor railings) \$215,500
 - 4. Jail/Detention Center Equipment Replacement & Remodel (2025 Epoxy Showers in Phase 1 at DC) \$225,000
 - 5. Health & Human Services Remodel (2025 2 Hallways, Lab & Break Room, 2026 Rooms 219 & 225) \$207,000
 - 6. UWGB Sheboygan Campus Parking Lot Reconstruction (2025 West Parking Lot & Lighting) \$360,992
 - 7. Office LED Lights (2025 Detention Center, 2026 Health & Human Services, 2027 Law Enforcement Center, 2028 Courthouse) \$1,206,000
 - 8. Elevator Upgrades (2026 Courthouse Public Elevator) \$453,000
 - 9. Law Enforcement Center Evidence Room Remodel (2026) \$400,000
 - 10. Courthouse Parking Lot Replacements (2026 Courthouse, 2027 LEC) \$317,900
 - 11. Law Enforcement Center Squad Garage and Sally Port Floor Replacement (2025 Squad Garage, 2026 Sally Port) \$180,000

After discussion, it was suggested to swap the Health & Human Services Remodel (Priority #5) with Elevator Upgrades (Priority #8). Moved by Supervisor Smith, seconded by Supervisor Jorgensen to approve the 5 Year Capital Plan as amended; motion carried with no nay votes.
