HAZMAT TEAM UPDATE

Steve updated the committee on a new member looking to join from Kiel Fire Department. This would help considering our contract with Manitowoc County. The Team has drills scheduled with NEMAK and Masters Gallery Foods.

PUBLIC HEALTH UPDATE

Jennifer gave updates covering upcoming training with the American Reed Cross for sheltering and vaccine clinics being scheduled at Uptown Social. Public Health is also closely monitoring measles outbreak in another Wisconsin county and starting to work on the Community Health Assessment survey which will be released in early 2026. Health and Human Services has also started testing with Rave for internal alerts.

DISCUSS RAVE AND THE INTEGRATED PUBLIC ALERT AND WARNING SYSTEM (IPAWS) Steve updated the committee on the use of Rave to date. We did use the system for severe weather at the P1 Boat races to evacuate the crowd.

UPDATE ON P1 BOAT RACE AND OTHER EVENTS

Jeff reviewed the boat races held in Sheboygan. Weather did impact the racing over the weekend. The City did stand up and EOC for coordination. This year a Temporary Flight Restriction for drones was implemented over the race course.

UPDATE ON HAZARD MITIGATION PLAN BRIC GRANT AND OTHER FEDERAL FUNDING Steve updated the committee that our Hazard Mitigation Plan is due to be updated so he completed a BRIC grant application. Since the application has been submitted, FEMA has completely cancelled the BRIC program. Wisconsin, along with other states, have filed a lawsuit to reinstate the BRIC program. EMPG funding was also placed on hold longer than normal. The Notice of Funding Opportunity was just released but it needs to be complete by the State and Approved by FEMA before September 30th.
