Discuss Adult Treatment Court Best Practice Standards

VI. Complementary Services and Recovery Capital Complementary services are strengths-based and help participants to develop the personal, familial, social, cultural, financial, and other recovery capital needed to help them sustain indefinite recovery and enhance their overall quality of life. Examples of complementary services may include assisted housing, family or significant other therapy, and vocational, educational, or life skills counseling. Treatment courts should routinely assess participants' recovery capital and deliver desired complementary services to enhance their long-term adaptive functioning and life satisfaction. Importantly, complementary services also include health-risk prevention measures that are proven to reduce overdose and death rates, transmission of communicable infections, and other serious

health risks. Treatment courts should not interfere with participant access to statutorily authorized and evidence-based health-risk prevention measures, which may include safer-sex education and training on and distribution of condoms and other safer-sex products, Narcan overdose reversal kits, fentanyl and xylazine test strips, and unused syringes.
