RE: Consideration of out of state travel for Treatment Court Team Members

Through our receipt of a federal grant to expand our Treatment Court Program, we are required to send a portion of our Treatment Court team to the National Association of Drug Court Professionals (NADCP) National Convention. In 2026 the convention is in Nashville TN on July 20-23, 2026. Expenses including travel, lodging, and meals are included in existing grant budgets. The only expense to Health and Human Services is work time of the HHSD staff who are attending: Morgan Rohde and Izayah Schoerner. Kendra Zipperer from Sheboygan PD will also be attending. Our grants also cover their costs, with the exception of work time which is the responsibility of their home department.

This convention is tailored to enhance skills, leadership, and training of justice system professionals at all intercept points. Sessions will cover all aspects of treatment courts and give our team access to the experts in the field.
