Chairperson Goehring called the meeting to order. He verified that the meeting notice was posted on May 7, 2013 at 8:30 A.M. in compliance with the open meeting law.

Consideration of Wood County Resolution Opposing An Entity from Foreclosing on Property Unless That Entity Itself has a Recorded Interest in the Property. County Administrator Adam Payne informed the committee that discussions are on-going concerning changes to the County's health insurance program. He also discussed the 2014 budget goals and targets. He expects to receive the bond rating from Moody's later this week.
